Objectives

- \checkmark discuss the relationship between professional boundaries and ethical practice
- ✓ demonstrate an understanding of the cost of boundary transgressions for clients, health professional, organization & profession and broader community

The process for each tailor-made plan is as follows:

- an initial interview between Dr McIntosh and the individual, following which a specific education program is developed. The initial interview takes approx.1.5 hours
- the plan usually consists of at least one written component (workbook consisting of short answer questions and scenarios, sometimes a reflective essay)
- attendance at one of our two day workshops if relevant to the specific undertaking the individual is to complete
 - * and / or completion of the Davaar internet tool on boundaries
- and education plan consisting of objectives, how those objectives will be met, time frame (identified during initial interview)
- dependent upon the reasons for the undertaking, the individual may be required to have a further 2-5 1:1 sessions (face to face is preferred or discussions over the phone with individuals who live interstate, overseas or far North Queensland. There will be a **minimum of 3 face to face, telephone or Skype sessions**)
- upon successful completion of the program, a report is generated to AHPRA as well a copy for the individual
- a certificate of attendance for 15 CPD is generated upon successful completion and receipt of full payment

The specific plan becomes a signed and dated agreement between Dr McIntosh (on behalf of Davaar Consultancy) and the individual. It is the responsibility of the individual to send the original signed plan to AHPRA for approval.

Cost of plan including resources, contact time (x 3 sessions), development of plan and report, and attendance at two day workshop is \$1,210.00. If further sessions are required these will be discussed at the end of the initial session and each extra session will be \$110.00 per session. **NB. Cancellation of appointments with less than 24 hours notice will incur the full hourly fee.**
